## I. Call to Order [President-Adam Tervola Hultberg]

## II. Approval of February Meeting Minutes [Denise Pesola]

Motion made to approve February minutes by Sebastian Tackling, seconded by Becky Weiland, motion passed.

#### **III.** Reports and Updates

A. Treasury Report [Adam T-H for Mike Dailey]

MBDA Expenses for 2009-2010 came in under budget.

Facility rent at Marshall High School came in under budget. \$5000 CPA-AUP evaluation will be done during Mike Dailey's term. MBDA is scheduling only one conference call in Jan. 2011 resulting in proposed budget change from \$1000 to \$250. Motion to approve Treasury Report made by Becky Weiland, seconded by Tara Michlitsch, motion passed.

## B. Membership Report [Adam T-H for Josh Anderson]

As of June 6, there are 388 MBDA members of whom 235 have paid. Reminder that MBDA membership runs from August to July. Agreed that an email clarification in July may be helpful however members already get a general membership reminder email.

A decision was made to revisit in the future how to manage region membership lists (i.e. does each region have a membership chair, would more uniformity between regions help?).

Dr. John Ginocchio wondered how many MBDA members are not MMEA members and if MBDA should reinstate MMEA/MENC membership for MBDA membership.

Motion to approve Membership Report made by David Miller, seconded by Sebastian Tackling, motion passed.

## C. Web Manager Report [Jeremy Mann]

Jeremy explained that our web-site host was bought and service has changed resulting in dissatisfaction with the service. MBDA Mentorship site is not being updated. Jeremy asked if MBDA should keep it? Reminder that region mailing lists must go through Jeremy and he can update them. For State memberships go though Adam first, then Jeremy. State membership lists cannot be used by non-members.

D. State Honor Band Event Report [Sebastian Tackling]

Successful 6-8, 9-10 Honor Band event at Marshall High School on April 17-18, 2010.

After discussion, MBDA strongly recommends repertoire that is currently in print. Suggestion made that P.O.P pieces can be considered with MBDA Board approval and adequate time frame.

Difficulty with t-shirt delivery in a timely manner. Scott Kummrow and Sebastian Tackling will discuss and decide how to handle in the future.

Discussion regarding section coaches being at rehearsals. Coaches seemed to appreciated doing both 6-8 and 9-10 sectionals.
